

**STATISTICAL REPORT FOR THE  
FISCAL YEAR OCTOBER 1, 2019 - SEPTEMBER 30, 2020**

During the fiscal year, October 1, 2019 to September 30, 2020, the Court of Federal Claims disposed of 804 complaint and 938 vaccine petitions. Except for a number of these cases in which no given amounts were claimed, the total amount claimed was \$12,915,441,000.00. Of the cases disposed, the court rendered judgments for claimants in the sum of \$12,960,014,109.75 (annuity amounts are included in this figure if available) of which \$7,004,524.83 carried interest. A number of these judgments were based on settlements between parties. The Court of Federal Claims rendered money judgments for the United States on counterclaims, offsets and/or sanctions in the sum of \$85,531,466.70. Under its non-monetary jurisdiction (bid protest jurisdiction), there were 120 cases filed and the court disposed of 116.

Case filings decreased in fiscal year 2020 for general jurisdiction cases and decreased for vaccine injury compensation cases. General<sup>1</sup> jurisdiction cases decreased by 13.3% while vaccine petitions decreased by 7%. There were 125 general jurisdiction cases, approximately 19.5%, with multiple plaintiffs and 10% involved intervening parties.

Total case terminations increased 18.8% from 1,466 in fiscal year 2019 to 1,742 in fiscal year 2020. Pending cases at the close of the fiscal year increased 2.7% from 4,217 on September 30, 2019 to 4,332 on September 30, 2020.
