DECISION AWARDING ATTORNEYS' FEES AND COSTS¹

On December 21, 2011, the parties filed a stipulation in which they agreed to settle the attorneys' fees and costs in this case.

In accordance with the General Order #9 requirements, petitioners state that they did not incur any costs to pursue their petition.

Vaccine Rule 18(b) states that all decisions of the special masters will be made available to the public unless they contain trade secrets or commercial or financial information that is privileged and confidential, or medical or similar information whose disclosure would constitute a clearly unwarranted invasion of privacy. When such a decision is filed, petitioner has 14 days to identify and move to redact such information prior to the document's disclosure. If the special master, upon review, agrees that the identified material fits within the banned categories listed above, the special master shall redact such material from public access.

The court finds the amount to be reasonable, hereby adopts the parties' stipulation, and awards compensation in the amount set forth therein. Pursuant to the stipulation, the court awards **\$22,300.00**, representing reimbursement for attorneys' fees and costs. The award shall be in the form of one check made jointly payable to petitioners and Hayes Law Offices in the amount of **\$22,300.00**.

In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court is directed to enter judgment herewith.²
