## UNPUBLISHED DECISION ON FEES AND COSTS<sup>1</sup>

<u>Diana S. Stadelnikas</u>, Maglio Christopher and Toale, PA, Sarasota, FL, for Petitioner; <u>Lara A. Englund</u>, U.S. Department of Justice, Washington, D.C., for Respondent.

Petitioner James Edward Oden filed an application for attorneys' fees and costs on July 20, 2011. The Court awards the amount to which respondent does not object.

Mr. Oden claimed that the influenza vaccine caused an adverse reaction and received compensation based upon the parties' stipulation. <u>Decision</u>, filed July 18, 2011. Because Mr. Oden received compensation, he is entitled to an award of attorneys' fees and costs. 42 U.S.C. § 300aa-15(e).

Mr. Oden seeks a total of **\$28,060.00** in attorneys' fees and costs for petitioner's counsel. Additionally, Mr. Oden filed a statement of costs in compliance with General Order No. 9,

stating that he incurred no litigation expenses while pursuing this claim. Respondent stated that she had no objection to this application for attorneys' fees and costs.

After reviewing the request, the court awards a check made payable to petitioner and petitioner's attorney in the amount of **\$28,060.00** for attorneys' fees and other litigation costs. The court thanks the parties for their cooperative efforts in resolving this matter.

The Clerk shall enter judgment accordingly.<sup>2</sup>
