

STATISTICAL REPORT FOR THE FISCAL YEAR OCTOBER 1, 2023 - SEPTEMBER 30, 2024

During the fiscal year, October 1, 2023, to September 30, 2024, the Court of Federal Claims disposed of 886 complaints and 1,491 vaccine petitions. Except for a number of these cases in which no given amounts were claimed, the total amount claimed was \$1,538,609,166,288.00. Of the cases disposed, the court rendered judgments for claimants in the sum of \$1,063,606,739.25 (annuity amounts are included in this figure if available) of which \$219,649,366.51 carried interest. A number of these judgments were based on settlements between parties. The Court of Federal Claims rendered money judgments for the United States on counterclaims, offsets and/or sanctions in the sum of \$274,205.42. Under its non-monetary jurisdiction (bid protest jurisdiction), there were 266 cases filed and the court disposed of 188.

Case filings decreased in fiscal year 2024 for general jurisdiction cases and increased slightly for vaccine injury compensation cases. General¹ jurisdiction cases decreased by 16.3% while vaccine petitions increased by 1.8%. There were 99 general jurisdiction cases, approximately 11.3%, with multiple plaintiffs and 11.1% involved intervening parties.

Total case terminations increased 14.7% from 2,072 in fiscal year 2023 to 2,377 in fiscal year 2024. Pending cases at the close of the fiscal year decreased 5.3% from 5,739 on September 30, 2023, to 5,435 on September 30, 2024.
